Mayor Paterson called the meeting to order at 7:00 pm

Mayor Paterson advised that this Public Meeting under the Planning Act was to consider County of Grey Plan of Subdivision Application File No. 42T-2015-01 – Saugeen Riverside Developments and Zoning By-law Amendment No. 2896-15 (File No. Z1-15 Saugeen Riverside Developments).

Mayor Paterson asked the Clerk for the method of notice for the Public Meeting. The Clerk advised that a notice for the Plan of Subdivision was circulated to all who live or own property within 120 metres of the proposed development location and to all commenting agencies on April 16, 2015, in accordance with the Planning Act regulations.

Comments were received from Historic Saugeen Metis, Union Gas, Saugeen Valley Conservation Authority, Hydro One, Westario Power Inc. and Rogers Communications Inc.

The Clerk advised that notice for the Public Meeting for Zoning By-law Amendment Z1-15 was advertised in The Post on May 28, 2015 and mailed to all commenting agencies on May 28, 2015, in accordance with the Planning Act regulations. The application was reviewed by the Planning Advisory Committee on April 1, May 19 and June 16, 2015.

Comments were received from Saugeen Conservation.

Don Tedford, Director of Development/CBO then highlighted Report PB-12-15 for members of Council. The purpose of Zoning By-law Amendment Z1-15 is to rezone lands described as Part of Lot 7, Concession 1, S.D.R. and known as 160 18th Avenue in the Town of Hanover from Institutional (I) to Residential Type 1 (R1h) Zone to allow construction of single detached dwellings on 32 lots created by a Plan of Subdivision.

Mayor Paterson asked if any members of the public wished to speak on this matter. Ron Davidson, Planner representing Saugeen Riverside Development came forward and stated that he and the project engineer, Stephen Cobean of WSP were in attendance to answer any questions or concerns that Council or the public may have

Mayor Paterson indicated that the floor is now closed to the public and that debate would take place among members of Council. After general discussion, the following recommendation was made.

He indicated it was discussed at the Board level and a communique from the CEO of Westario will be coming out soon. Deputy Mayor Hicks was in favour of putting a resolution forward to Westario to encourage them to work with United Way. Councillor Fitzsimmons agreed. Councillor Hambly suggested that Council wait until they receive the communique. Council requested that this issue be brought forward to the July 13th Council meeting.

This resolution shall expire twelve (12) months after its adoption by Council.
