2.1 Report PB-03-16 – Zoning By-Law Amendment No. 2923-16 (File No. Z1-16 Ward, Steven & Jessica)

Mayor Paterson advised that this Public Meeting under the Planning Act was to consider Zoning By-law Amendment No. 2923-16 (File No. Z1-16 Ward, Steven & Jessica).

Mayor Paterson asked the Clerk for the method of notice for the Public Meeting. The Clerk advised that notice for the Public Meeting was advertised in The Post on February 25, 2016 and mailed to all commenting agencies on February 25, 2016, in accordance with the Planning Act regulations. The application was reviewed by the Planning Advisory Committee on February 2, 2016. Comments were received from County of Grey Planning and Development Department and the Saugeen Valley Conservation Authority. Further comments were received by letter from Marion Fry and Lorne Fry on March 21, 2016.

Don Tedford, Director of Development/CBO then highlighted Report PB-03-16 for members of Council. The purpose of Zoning By-law Amendment Z1-16 is to rezone lands described as Part of Park Lot 1, Registered Plan 741 and known as 238 7th Street, from Residential Type 5 (R5) to Residential Type 4 Site Specific (R4-XX) Zone to allow four townhouse type dwellings to be constructed on the lands.

Mayor Paterson asked if any members of the public wished to speak on this matter. No one came forward.

Mayor Paterson indicated that the floor is now closed to the public and that debate would take place among members of Council. After general discussion and taking into consideration comments received from adjacent property owner Marion Fry, the following recommendation was made.
