4.1 Report PB-02-18 – Public Meeting for Zoning By-law Amendment (File No. Z1-18 1953521 Ontario Inc. c/o Tremble, Don)

Mayor Paterson advised that this Public Meeting under the Planning Act was to consider Zoning By-Law Amendment File No. Z1-18 1953521 Ontario Inc. c/o Tremble, Don.

Mayor Paterson asked the Clerk for the method of notice for the Public Meeting. The Clerk advised that notice for the Public Meeting was advertised in The Post and mailed to all commenting agencies on February 8, 2018, in accordance with Sections 17 & 34 of the Planning Act regulations.

The application was reviewed by the Planning Advisory Committee on February 13, 2018. Comments were received from Grey County Planning and Development Department.

Don Tedford, Director of Development/CBO then highlighted Report PB-02-18 for members of Council. The purpose of the Zoning By-law Amendment is to rezone the lands described as Part of Lot 86, Registered Plan 702 from Residential Type 3 (R3) Zone to Residential Type 2 Site Specific (R2-24) Zone to permit the severance of the property to create a new detached dwelling and to retain the existing duplex with a reduced lot area and rear yard. Consent Application Number B1-18 is related to this zoning by-law amendment.

Mayor Paterson asked if any members of the public wished to speak on this matter. No one came forward. It was noted that Don and Kevin Tremble where in attendance to hear the proceedings.

Mayor Paterson indicated that the floor is now closed to the public and that debate would take place among members of Council. After general discussion, the following recommendation was made.

AND THAT the appropriate by-law be presented at the March 19, 2018 regular meeting of Council.

Mayor Paterson asked the Clerk for the method of notice for the Public Meeting. The Clerk advised that notice for the Public Meeting was advertised in The Post and mailed to all commenting agencies on February 8, 2018, in accordance with Sections 17 & 34 of the Planning Act regulations.

The application was reviewed by the Planning Advisory Committee on February 13, 2018. Comments were received from Grey County Planning and Development Department and Saugeen Valley Conservation Authority.

Don Tedford, Director of Development/CBO then highlighted Report PB-03-18 for members of Council. The purpose of the Zoning By-law Amendment is to rezone the lands described as Lots 25 to 32, Registered Plan 16M-56 from Residential Type 3 (R3) to Residential Type 3 Site Specific (R3-25) to allow the semi-detached dwellings to be constructed on the lands known as 695 to 704 and 693 to 705 25th Avenue with a lesser exterior side yard, front yard, rear yard and increased lot coverage of 48%.

5. **HEALTH & SAFETY MESSAGE** – (Deputy Mayor Hicks)

LIFTING LESSONS – Avoid back injury by using these simple lifting techniques at work or home:

- Assess the load small doesn't always mean light. If you need help, ask for it or use a dolly or lift.
- Check out your path make sure there is a clear path with no obstacles in front of you.
- Get close to it bend your knees to get to the object's level and bring the load close to your body before you lift. Never reach up or down to lift an object.
- Use your core and legs to lift never use your back to pick up an object.
- Don't rely on a back belt it won't help if you lift a load incorrectly.
- Carry the load straight and even not to the side or on 1 shoulder.
