# Notice of Joint Public Meeting

## Municipal Boundary Restructuring Proposal


(Municipal Act, Sections 172 and 173)

Take notice that the Corporation of the Town of Hanover (Hanover) and the Municipality of West Grey (West Grey) are working together to build communities for the future and grow prosperity in the region.

The municipalities are considering the expansion of the Hanover boundary to encompass the following lots in West Grey in their entirety.

Lots 1 to 10, Concession 3 NDR, Part lots 11 to 13, Concession 2 NDR, Part lots 16 to 19, Concession 1 NDR, Part lots 8 to 11, Concession 1 SDR, Lots 12 to 17, Concession 1 SDR and Lots 9 to 17, Concession 2 SDR, Geographic Township of Bentinck.

The proposed 'mutual prosperity lands' highlighted in purple are the lands that are being considered for transfer from West Grey to Hanover in exchange for financial compensation from Hanover to West Grey.
