

NOTICE OF A PUBLIC MEETING

CONCERNING A PROPOSED CONSENT

TAKE NOTICE that the Committee of Adjustment for the Corporation of the Town of Hanover will hold a public meeting, via Zoom, on:

to consider the following Consent Application under Section 53 of the Planning Act, RSO 1990 as amended.

Consent Application No. B1-23 applies to lands described as Lot 3, 4 and 15 to 18, Part of Lot 72, 73, Concession 1, South Durham Road, block 3 of Registered Plan 772, Parts 8, 10 of Reference Plan RP17R1584 and known as 101 10th Street in the Town of Hanover, in the County of Grey.

The purpose of Consent Application No. B1-23 is to sever & retain land for the purposes of creating a new lot and create an easement on the retained lands to provide a right of way for access to the severed lands on Fourth Avenue.

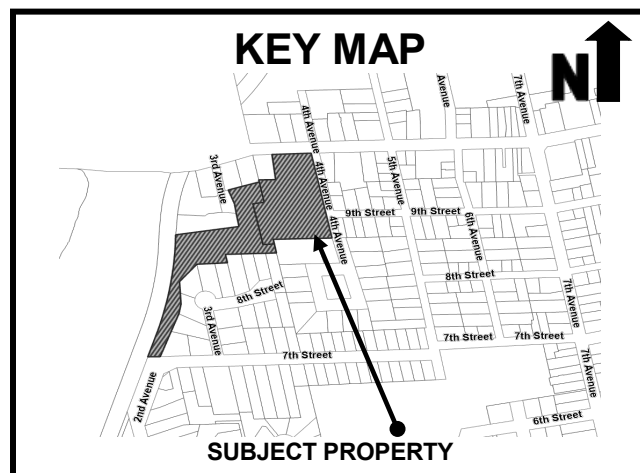
All submissions received in writing, and those opinions expressed at the Public Meeting, will be considered prior to the Committee of Adjustment decision.
