## Accessible Portable Suitcase Ramp

### **Subsidy Criteria:**

For members of the Hanover Chamber of Commerce in good standing.

Subsidy amount limited to **\$250.00**, and available only once per member.

Funds are limited and will be allocated on a first come first serve basis.

Subsidy is available to any Hanover Chamber of Commerce Member purchasing an Accessible Portable Suitcase Ramp (cost range of \$400. to \$1,000.). Ramp must be CAS approved.

Only purchases with receipts after January 1, 2025 will be considered for this Subsidy Program, with end date TBD. Please contact the Chamber Office prior to purchase if a grant subsidy is a priority for your purchase: 519 364-5777.

Applicant must submit a copy of the invoice noting the business supplying ramp, ramp specs and proof of payment, along with the completed application form.
